TERMS AND CONDITIONS OF USE

• About the Application

- Welcome to Hwzzit (the 'Application'). The Application sends reminders to the users and displays the information about Hwzzit. (the 'Services').
- The Application is operated by Hwzzit. (ABN 90378281229). Access to and use of the Application, or any of its associated Products or Services, is provided by Hwzzit. Please read these terms and conditions (the 'Terms') carefully. By using, browsing and/or reading the Application, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Application, or any of its Services, immediately.
- Hwzzit reserves the right to review and change any of the Terms by updating this page
 at its sole discretion. When Hwzzit updates the Terms, it will use reasonable endeavours
 to provide you with notice of updates to the Terms. Any changes to the Terms take
 immediate effect from the date of their publication. Before you continue, we recommend
 you keep a copy of the Terms for your records.
- Acceptance of the Terms
- You accept the Terms by using or browsing the Application. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Hwzzit in the user interface.
- Registration to use the Services
 - In order to access the Services, you must first register for an account through the Hwzzit (the 'Account').
 - As part of the registration process, or as part of your continued use of the Services, you
 may be required to provide personal information about yourself (such as identification or
 contact details), including:
 - You warrant that any information you give to Hwzzit in the course of completing the registration process will always be accurate, correct and up to date.

- Subject to local applicable laws, Hwzzit reserves the right to discontinue or cancel your membership at any time and may suspend or deny, in its sole discretion, your

• Dispute Resolution

- Compulsory:
- If a dispute arises out of or relates to the Terms, either party may not commence any Tribunal or Court proceedings in relation to the dispute, unless the following clauses have been complied with (except where urgent interlocutory relief is sought).
- Notice:
- A party to the Terms claiming a dispute ('Dispute') has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute.
- Resolution:
- On receipt of that notice ('Notice') by that other party, the parties to the Terms ('Parties') must:
 - Within 14 days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;
 - If for any reason whatsoever, 14 days after the date of the Notice, the Dispute has not been resolved, the Parties must either agree upon selection of a mediator or request that an appropriate mediator be appointed by the President of the Australian Mediation Association or his or her nominee;
 - The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as a pre-condition to the mediation commencing. The Parties must each pay their own costs associated with the mediation;

- The mediation will be held in 13 Cassowary Ave, Pakenham 3810
- Confidential
- All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiations for the purpose of applicable laws of evidence.
- Termination of Mediation:
- If 2 weeks have elapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either Party may ask the mediator to terminate the mediation and the mediator must do so.
- Venue and Jurisdiction
- The Services offered by Hwzzit is intended to be viewed by residents of Australia. In the event of any dispute arising out of or in relation to the Application, you agree that the exclusive venue for resolving any dispute shall be in the courts of Victoria, Australia.
- Governing Law
- The Terms are governed by the laws of Victoria, Australia. Any dispute, controversy, proceeding or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed, interpreted and construed by, under and pursuant to the laws of Victoria, Australia, without reference to conflict of law principles, notwithstanding mandatory rules. The validity of this governing law clause is not contested. The Terms shall be binding to the benefit of the parties hereto and their successors and assigns.
- Independent Legal Advice
- Both parties confirm and declare that the provisions of the Terms are fair and reasonable and both parties having taken the opportunity to obtain independent legal advice and declare the Terms are not against public policy on the grounds of inequality or bargaining power or general grounds of restraint of trade.
- Severance
- If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
